1. The important case against the promoters of the corona panic!

The case against the promoters of the corona panic! - the exaggeration of the danger and spread of corona virus covid-19, has created enormous social damages, the greatest one is the danger of democracy being replaced by fascist totalitarian government models

There are doctors and experts that have disagree with the information about corona that the WHO, CDC, the media and governments have been presenting, they have not been allowed to speak. Now European lawyer is suing the promoters of the corona panic for Crimes Against Humanity, he presented his case online the 3rd of October 2020

The WHO has said that this is a dangerous pandemic, and that we should use the PCR test to measure it. But there is no evidence that the corona flu is more dangerous than the common flu, 46 doctors and experts show that the mortality rate is 0.01%, and not 3.4% as the World Health Organization (WHO) says". And there is no documentation for the reliability of the PCR test (that is used to measure people with corona flu), PCR tests have never been recognized for diagnosis of virus, and these test are unreliable, they show far more positives than is the case.

Lawyer Reiner Fuellmich is suing the leader of WHO for fraud in regards to exaggerating the danger and spread of corona flu (covid 19), to be exact he is suing the three main promoters of the "Corona Panic". I send it (together with documentation) to Danish and Swedish mainstream media, as well as USA mainstream media, the 28-29 october, no mention yet!

Who is Reiner Fuellmich and the Corona Investigative Comitee? Reiner Fuellmich a renown trial lawyer against fraudulent corporations such as Deutsche bank, VW, and Cunard and Niagara. Also one of four members of the German Corona Investigative Committee. Since July 10, 2020, this committee has been listening to a large number of international scientists and experts' testimony. He came to the conclusion that the danger and spread of the corona virus are being greatly exaggerated, and the measures based on this are the greatest restriction on our fundamental human rights since World War II. Calling it "The Corona Scandal", just the "Swine Flue Scandal" of 2009, though this time much more serious social damages are taking place, he is now suing the promoters of the "corona panic" for "Crimes Against Humanity". There are many experts that have disagreed with WHO from the beginning, they have not been able to come forth, it seems the media is deliberately ignoring this case and its important facts, the video has been one month online, and still no news about it in mainstream media that I can see.

These are some of the findings in the Corona Investigative Comitee, let me give you a short resume of what these doctors and experts which disagree with WHO say about the danger of the corona flu, and the reliability of the PCR Test (corona test)

1. How dangerous is the corona flu really? To clarify, covid-19, is a dangerous disease, just like the seasonal flu, and just like the seasonal flu it may sometimes take a severe clinical course and will sometimes kill patients. However, as autopsies have shown, almost all been caused by serious pre-existing conditions and almost all of the people who had died, had died at a very old age, just like in Italy, meaning they had lived beyond their average life expectancy. There was a real wave of disease in March and April but since then everything has gone back to normal. In the free ebook "A Tribute to the Corona Whistle Blowers" 46 doctors and experts show that the mortality rate is 0.01%, and not 3.4% as the World Health Organization (WHO) says". The mortality of corona is equivalent to that of the seasonal flu. -- And what is more, hear this, the WHO accidentally confirmed this in a press conference the 5th October 2020, by the numbers they presented, but few made the maths, the maths shows that the infection fatality rate is 0.14%. That is over 24 times lower than the WHO's "provisional figure of 3.4%" back in March.

2. What is the significance of a post-positive PCR test (corona test)? We have learned that PCR tests, contrary to the assertions of Drosten, Wieler and the WHO, do not give any indication of an infection with any virus. PCR tests expressly not approved for diagnostic purposes, as is correctly noted on leaflets coming with these tests. Even the United States CDC agrees with this. Even Drosten himself declared in an interview in 2014, that these PCR tests are so highly sensitive that even very healthy and non-infectious people may test positive. A number of highly respected scientists worldwide assume that there has never been a corona pandemic but only a PCR test pandemic. Dr Yeadon in his piece: 'Lies, Damned Lies and Health Statistics - the Deadly Danger of False Positives' explains the complete unsuitability of the test for the detection of infectious diseases, covid 19 has tested positive in goats, sheep, papayas and even chicken wings.

3. A Social Catastrophe - I don't have to remind you of all the damage that has been produce as a result of believing WHO's exaggerated danger of corona and its spread, and governments locking down our countries for so long: Bankruptcies of small and medium-sized businesses, which form the backbone of the economy, in Germany alone, 500 000 to 800 000 bankruptcies are expected in the fall. Children are traumatized en masse, made to feel responsible for death of their parents and grandparents if they do not follow the corona rules. The doubling of global poverty, what do you think people in third world countries will eat, when they can not go to work? The danger of democracy being replaced by fascist totalitarian government models.

Who decided the lockdown and on what grounds?

Lets go back in time. A judge can allow a class-action lawsuit to go forward if common questions of law and fact make up the vital component of the lawsuit.

Through an international lawyers' network, which is growing larger by the day, the German group of attorneys provides to all of their colleagues, in all other countries, free of charge, all relevant information, including expert opinions and testimonies of experts showing that the PCR tests cannot detect infections and they also provide them with all relevant information as to how they can prepare and bundle the claims for damages of their clients so that they too can assert their clients claims for damages either in their home countries, courts of law, or within the framework of the class action as explained above.

These scandalous corona facts gathered mostly by the corona committee and summarised above are the very same facts that will soon be proven to be true, either in one court of law or in many courts of law, all over the world. These are the facts that will pull the masks off the faces of all those responsible for these crimes.

2. Experts speak about the spread of disinformation on covid-19 and its dangers

World Doctors Alliance - Open letter to the UK Government, Governments of the World and the Citizens of the World to stop all lockdown measures immediately

An independent non-profit alliance of doctors, nurses, healthcare professionals and staff around the world who have united in the wake of the Covid-19 response chapter to share experiences with a view to ending all lockdowns and related damaging measures and to re-establish universal health determinance of psychological and physical wellbeing for all humanity.

Letter: Open letter to the UK Government, Governments of the World and the Citizens of the World to stop all lockdown measures immediately

We the undersigned call upon the UK government, governments of the World and the Citizens of the World, to stop all lockdown measures immediately. We were told initially that the premise for lockdown was to 'flatten the curve' and therefore protect the NHS from being overwhelmed. It is clear that at no point was the National Health Service (NHS) in any danger of being overwhelmed, and since May 2020 covid wards have been largely empty; and crucially the death toll from covid has remained extremely low. We now have hundreds of thousands of so-called 'cases', 'infections' and 'positive tests' but hardly any sick people. Recall that four fifths (80%) of 'infections' are asymptomatic (1) Covid wards have been by and large empty throughout June, July, August and September 2020. Most importantly covid deaths are at an all-time low. It is clear that these 'cases' are in fact not 'cases' but rather they are normal healthy people. So-called asymptomatic cases have never in the history of respiratory disease been the driver for spread of infection. Rather it is symptomatic people who spread respiratory infections - not asymptomatic people. (2) It is also abundantly clear that the 'pandemic' is basically over and has been since June 2020. (3) We have reached 'herd' immunity and therefore have no need for a vaccine.

We have safe and very effective treatments and preventative treatments for covid, we therefore call for an immediate end to all lockdown measures, social distancing, mask wearing, testing of healthy individuals, track and trace, immunity passports, the vaccination program and so on. There has been a catalogue of unscientific, non-sensical policies enacted which infringe our inalienable rights, such as - freedom of movement, freedom of speech and freedom of assembly. These draconian totalitarian measures must never be repeated.

Lockdown

- Covid has proved less deadly than previous influenza seasons – There were 50,100 flu deaths from December 2017 to March 2018 in England and Wales. There were 80,000 flu deaths in 1969. To date we have circa 42,000 covid related deaths in the UK.
- We have never locked down society for a respiratory virus before.
- The basis for lockdown was a mathematical model by Professor Neil Ferguson. His modelling which predicted half a million deaths in the UK has been roundly condemned as being not fit for purpose. His estimated death figures were clearly wrong by a factor of 10 or 12 times. (1)
- Professor Ferguson's modelling was not even peer reviewed before being acted upon by several nations. Eminent epidemiologists such as Professor Gupta from Oxford University were ignored, they estimated the death count would be far lower in the UK.
- Professor Ferguson has a long track record of woeful modelling he was entirely wrong about sars, mers, mad cow's disease (CJD), and swine flu. Why did the world listen to him again? (2)
- Countries which did not lock down Sweden, Japan, Taiwan, South Korea and Belarus have all done significantly better than us in terms of percentage of population deaths. They also have herd immunity and intact economies.
- Lockdown did not save lives, and this has been published in the Lancet '...in our analysis, full lockdowns and wide-spread COVID-19 testing were not associated with reductions in the number of critical cases or overall mortality.' (3)
- The vast majority of deaths occurred in elderly and very elderly people
- The vast majority of deaths occurred in people with pre-existing serious health issues such as cancer, cardiovascular disease, Alzheimer's, diabetes etc
- Covid poses virtually zero risk to the under 45's who have more chance of being struck by lightning than dying from covid.
- Covid poses a very small risk for healthy under 60 year olds who have a greater chance of accidental drowning than dying from covid.
- The entire nation was essentially placed under house arrest. We have never isolated the healthy before.
- Isolating the sick and those who are immunocompromised makes sense. Isolating the healthy has hampered the establishment of herd immunity and makes no sense.
- To put it into perspective we had 115,000 smoking related deaths in the UK in 2015 compared to the 42,000 deaths from covid.
- We usually have around 600,000 deaths every year in the UK, roughly 1600 deaths per day.

Collateral damage the cure is worse than the virus

- Placing the public under virtual house arrest has caused untold damage to both physical and mental health. (1)
- Ventilating patients instead of oxygenating patients proved to be a deadly policy and an unwarranted failure. Ventilation resulted in many unnecessary deaths. (2)
- Sending infected people from hospitals to care homes placed the elderly and frail under unnecessary risk and resulted in many unnecessary deaths. (3)
- Blanket Do Not Resuscitate (DNR) orders were imposed on thousands of people without their consent nor the consent of their families – this is both unlawful and immoral and lead to unnecessary deaths in care homes. (4)
- Hospitals became essentially 'covid only' centres vast numbers of patients were wilfully neglected, resulting in many thousands of unnecessary deaths. (5)
- The government's own report estimates that some two hundred thousand (200,000) people will die as a direct result of lockdown – not the virus. Hospitals being closed, suicide and poverty will result in more deaths than the virus. (6)
- The cure is worse than the disease!

Death certificates (1)

- The majority of people who died had significant comorbidities, such as Alzheimer's, cancer, cardiovascular disease and diabetes.
- Counting death certificates with a 'mention' of covid as being a death caused by covid is a gross misrepresentation of the facts and has vastly over exaggerated the death toll.
- The rules for the signing of death certificates have been changed solely for covid by the Coronavirus 2020 Act.
- Doctors do not even need to have physically seen the patient in order to sign death certificates.
- The Act has removed the need for a confirmatory medical certificate for cremations.
- Autopsies have virtually been banned, no doubt leading to misdiagnosis of the true cause of deaths; and also reducing our understanding of the disease itself.
- Worse still, care home staff who largely have no medical training are able to give a statement as to the cause of death.
- Covid was put on death certificates merely on the 'suspicion' of people having covid. This may well be unlawful, since it is a crime to falsify death certificates.
- People who die within 28 days of a positive pcr test are deemed to have died from covid, even if they die in a car crash or from a heart attack; clearly over inflating the death toll (2)

Economic ruin

- Reports now estimate that as many as six and a half million (6,500,000) people in the UK will lose their jobs as a result of lockdown. (1)

- It is well known that poverty directly adversely affects health, we can expect to see many people suffering with poor health and resulting in many premature deaths, as a direct result of lockdown.

Censorship

- Government have acted maliciously in censoring doctors, nurses and NHS staff. The people have the perfect right to hear what is going on in hospitals, and the medical profession have a duty to look after the public and to reassure them. (1)
- The medical profession have not been allowed to let the public know that covid wards have been empty for months, nor that covid deaths have reached an all-time low for months, and this has unnecessarily added to the public's distress and anxiety.
- Doctors and scientists with views that differ from the government narrative have had their videos and articles removed from the internet

Testing - False positives

- PCR tests cannot be verified for accuracy as there is no 'gold standard' against which to check them. The virus has not been purified. (1)
- PCR tests cannot detect viral loads and are prone to false positives. (2)
- A positive PCR test does not mean that an individual is infected nor infective. (3)
- In fact approximately 90% of the PCR positive 'cases' are false positives. We therefore have no second wave and no pandemic. (4, 5)
- The government's report estimates a false positive rate of between 0.8 to 4.0 % using data from other viral infections – not from covid (6)
- Viral fragments may remain in people's bodies for several weeks following recovery from infection. (7)
- The crisis will never end if we are waiting for zero positive tests. Everyone has probably had a cold caused by a coronavirus and will likely have a few viral fragments matching those of the cousin SARS-CoV-2 virus (8)
- Testing healthy asymptomatic individuals is non-sensical, unscientific and a colossal waste of money. The governments moon shot daily testing program will cost £100 Billion roughly two thirds of the annual NHS budget.
- Antibody testing is not the gold standard as many people have T-cell immunity, and antibodies may not circulate following recovery from infection.

Hydroxychloroquine

- The controversial drug Hydroxychloroquine (HCQ) has been unfairly smeared, by the WHO, CDC, NIH and the media.
- However HCQ has very firm support from, amongst others: Professor Harvey Risch epidemiologist from Yale, The American Association of Physicians and Surgeons (AAPS), American Frontline Doctors, the Henry Ford Health System and Professor Didier Raoult microbiologist and infectious disease specialist - to name but a few. (1)
- The Lancet was even forced to retract a study on HCQ after it was revealed by the Guardian newspaper that they had been completely fabricated and written by a sci-fi writer and a porn star. Even following this astounding revelation HCQ was still banned in most countries. (2)
- HCQ according to AAPS has a ninety per cent (90%) cure rate when given early and alongside zinc (3)
- HCQ is safer than many over the counter drugs such as aspirin, Benadryl and Tylenol.
- The AAPS also point out that there has never been a vaccine as safe as HCQ. (4)
- HCQ has been licensed for over sixty years and has been safely used by billions of people worldwide. There is a very small risk of arrhythmia which is easily monitored.
- Why was HCQ banned then? Could it be that there are no huge profits to be made from this out-of-patent drug?
- HCQ was used to great effect in the Sars1 outbreak of 2005 (5)
- In short had HCQ been available then there would not have been a pandemic !

Prevention

- Preventative measures such as hydroxychloroquine or vitamins D, C and zinc should have been recommended for the public. (1)
- Early calcifediol (25-hydroxyvitamin D) treatment to hospitalized COVID-19 patients significantly reduced intensive care unit admissions (2)
- Vit D reduces the severity of covid. (2,3)
- Voluntary isolation of the frail - should they so choose; in combination with preventative measures would have been a far better strategy. The rest of society could and should have continued as normal.

Vaccine

- A rushed vaccine is clearly not in the public's best interest
- Indemnifying vaccine manufacturers against all liability is also clearly not in the public's best interest

Conflicts of interest

- Chief Scientific Officer Sir Patrick Vallance has £600,000 worth of shares in GSK Glaxo Smith Klein. He has in recent years sold £5 million of shares in GSK which he 'earned' whilst chief of GSK (1)
- Sir Chris Whitty, Chief Medical Officer UK, accepted over £30 million in funding from the Bill and Melinda Gates foundation to study malaria vaccines. (2)
- It has become clear that members of SAGE, Public Health England (PHE), World Health Organisation (WHO), Centre for Disease Control (CDC), National institute for Health (NIH) etc have many conflicts of interests. They all accept very large 'donations' from the pharmaceutical and vaccine industry. These conflicts of interests may well have effectively corrupted their integrity. (3)
- It is also clear that governments are heavily lobbied by the pharmaceutical industry and the vaccine industry, again this may have compromised their integrity. (4)

Cui bono? Who benefits?

- Vaccine manufacturers will make trillions from this, as will track and trace manufacturers, and the pharmaceutical industry stand to make trillions from covid testing.
- Prime minister Boris Johnson announced the new 'moon shot' testing will cost £100 Billion, approximately two thirds of the annual NHS budget.
- Surely these vast sums would be far better spent on treating all of the neglected patients who have been wilfully neglected during lockdown and who now face huge waiting lists.

Conclusions

We have effective and safe treatments and preventative medications for covid, therefore there is no need for any lockdown restrictions and associated measures. The pandemic is essentially over as can be seen by the consistent low death rate and hospital admissions over the past four months.

We demand the immediate and permanent ceasing of all lockdown measures. Lockdowns do not save lives, that is why they have never been used before. Civil liberties and fundamental freedoms have been unnecessarily removed from the public and this must never happen again.

Preventative measures such as Hydroxychloroquine, vitamin C, Vitamin D and zinc must be made readily available to the public.

Isolation must be voluntary. People are perfectly capable of making their own assessment of the risks and must be free to go about their lives as they so choose. People must have the right to choose whether to isolate or not. Likewise, businesses must have the right to remain open if they so choose.

We demand that doctors, nurses, scientists and healthcare professionals must be permitted free speech and never be censored again.

Professor Mark Woolhouse epidemiologist and specialist in infectious diseases, Edinburgh University Member of the Scientific Pandemic Influenza Group on Behaviours, that advises the Government stated that - ‘...Lockdown was a monumental disaster on a global scale. The cure was worse than the disease.’ ‘I never want to see national lockdown again. It was always a temporary measure that simply delayed the stage of the epidemic we see now. It was never going to change anything fundamentally, however low we drove down the number of cases,’ ‘We absolutely should never return to a position where children cannot play or go to school.’

I believe the harm lockdown is doing to our education, health care access, and broader aspects of our economy and society will turn out to be at least as great as the harm done by Covid-19.’(1)

The World Doctors Alliance agree fully with Prof Woolhouse’s assertions, he is right! We must never lockdown again!

As authoritarianism spreads, as emergency laws proliferate, as we sacrifice our rights, we also sacrifice our capability to arrest the slide into a less liberal and less free world. Do you truly believe that when the first wave, this second wave, the 16th wave of the coronavirus is a long forgotten memory, that these capabilities will not be kept? -Edward Snowden (source) Snowden points out that just like 9/11, the coronavirus will be used to heighten even more surveillance and security measures that won't go away. I am sure many measures that are being put in place, just as they were put into place after 9/11, will remain classified and completely hidden from the citizenry. That's why people like Edward Snowden are so important.

We are also seeing an authoritarian type of dictator policing the internet as well. Dr. Ron Paul had a piece that was recently flagged as 'false news' for simply sharing his opinion. The coronavirus pandemic is exacerbating threats to press freedom around the world, with authoritarian states suppressing details of the outbreak. Paris-based Reporters Without Borders (RSF) said in its annual press freedom rankings the pandemic was "highlighting and amplifying the many crises" already casting a shadow on press freedom. The outbreak had encouraged some regimes to "take advantage of the fact people are stunned and mobilisation has weakened to impose measures that would be impossible to adopt in normal times", RSF secretary general Christophe Deloire told AFP.

The response to the pandemic has resulted in unprecedented expansion of government power. Advocates of small government worry that the state will be reluctant to give up that power once the crisis is over, as has often been the case historically. At least 84 countries have declared a state of emergency in response to the pandemic, leading to fears about misuse of power. Reporters Without Borders has claimed that 38 countries have restricted freedom of the press as a result. Other examples include banning mass protests, postponing elections or holding them while the opposition cannot effectively campaign, selectively enforcing lockdown rules on political opponents, handing out relief payments to political supporters, or scapegoating minorities. Many countries have also unveiled large-scale surveillance programs for contact tracing, leading to worries about their impact on privacy.

The RSF based in Paris said that the pandemic has amplified and highlighted many crises and over shadowed freedom of the press. Pointing the global impact of the coronavirus crisis, in a statement, the high representative of the EU, Josep Borrell reminded that the pandemic should not be used to justify the limitation of democratic and civil atmosphere and respecting the rule of law and international commitments. It should not limit the freedom of speech and media and also access to the information, both online and offline. These measures should not be used for restriction of human rights advocates, reporters, media staffs, and institutions of civil societies.

5. The danger of the situation - What will happen if we don't intervene?

a) Coronavirus: Silent Obedience Will Destroy Us - Dr Vernon Coleman - The first camp, which is the largest, contains the people who are terrified and who think lockdowns are a great idea. The second camp is the smallest of the three, people who believe the coronavirus scare has been wildly oversold. In the third camp, which is the second largest group, are the people who don't quite know what to think or who don't have the courage to face the facts ... It is the people in this third group I honestly can't understand. This is a crucial time. It affects our lives now and for the foreseeable future. Generations ahead will be affected by what we do now. The basic question is: are we fighting a virus or are we fighting our governments? It's not a question you can ignore. Everyone has to take sides.

The world is now divided into three camps.

THE FIRST CAMP, which is the largest, contains the people who are terrified and who think lockdowns are a great idea. They honestly believe that if we don't all stay indoors and keep the windows closed then the plague will kill us all. Some worry about the lockdown ending and believe that everyone should stay locked in forever or until the scientists confirm either that the last bug has been killed or that they have a safe and effective jab available.

This camp includes the trade union leaders who are insisting that their members will not go to work until they have all been equipped with the full regalia: gowns, hats, goggles, gloves and, for all I know, white rubber surgical boots and special socks. Moreover, they insist that their members must be kept six feet away from one another at all times.

And the camp includes those parents who say they won't allow their children to attend school when the schools reopen.

It is these people who write rude things and put thumbs down signs on my videos. (I do find it difficult to understand how and why people insist on putting a 'disapprove' sign on a video which is packed with facts. How can anyone object to facts? Perhaps they just press the wrong button by mistake or maybe they come from one of those countries where the thumbs down sign is a sign of approval.)

The ones who want the lockdowns to continue are consumed by terror and believe everything the politicians say. They would happily drink the deadly koolaid if they were told it would keep them all safe. These are the folk who will enthusiastically sell their privacy, their remaining freedom and their souls, and enthusiastically sign up for the privacy eating mobile phone apps and whatever jabs are on offer. I'm not mocking. I understand why these people feel the way they do. They have been terrified out of their wits by ruthless professionals bombarding them with a potent mixture of pseudoscience and scare stories, and with exaggeration and misdirection. There is much talk these days of conspiracies and fake news – well, believe me, in my opinion no nutty website produces as much misleading news as the BBC.

I know of nothing as institutionally biased as the BBC. For example, I saw yesterday on the BBC website that the coronavirus has now infected four million people around the world. To the ignorant this probably seems a huge and frightening number. No one bothered to point out that the flu can infect 45 million people in America alone. (And those 45 million people, let us remember, were all ill enough to need to report to their doctor.) The figure for the whole world is one of those huge numbers with loads of noughts that sounds like America's national debt. But in one year ten times as many people can get the flu in America alone as have now been infected with the coronavirus world-wide. Those are proper facts and that's called putting things into perspective.

And here's another good fact. Between the middle of March and the middle of April in 1919 there were in New York State around 13,000 deaths from heart disease, cancer, flu, accidents, stroke, flu, murder and so on. In the same period in 2020 the number of deaths from all those diseases came to less than 5,000. But there were a lot of deaths from Covid-19. How can this be? Have doctors in New York suddenly found secret cures for cancer and heart disease and everything else? Or am I being unduly cynical in wondering if it is possible that a lot of people who really died of something else have been officially listed as having died of the coronavirus?

The statistics are bad enough but the thing that really infuriates me is that no one in authority seems to care that real people are suffering because of these stupid policies. In newspapers and on the TV we have been exposed to a lot of pictures of people who tragically died with the coronavirus and a few who died of it but we haven't had any pictures of the people with cancer or heart disease or whatever else, who are going to die because their treatment has been stopped. There are people who are going to die sooner than they should because their treatment has been halted. Their pictures won't appear on TV or in the tabloids. And there already are at least ten times as many people in this category as there are in the Covid-19 category.

In the UK, the hospitals are half empty and those doctors and nurses not dealing with coronavirus patients are standing around wondering where all the patients went. Politicians are enjoying their new power and they don't give a damn about you and me. If this false crisis ever ends, waiting lists for urgent surgery are going to be years long. Millions will be waiting for life-saving surgery, radiotherapy and so on. Doctors and nurses know this is happening and they don't want it to happen. But they are doing what they are told to do by moronic advisers and bureaucrats and politicians who probably goose step to work every morning.

And as a few Germans discovered 75 years ago, it isn't enough to say I was just doing what I was told. Doctors and nurses should stand up and speak out. I know it may endanger your career (I buggered up my career long, long ago by speaking out) but this is far more important than anyone's career. And when the time comes to decide who screwed up and who is responsible for hundreds of thousands of unnecessary deaths, the politicians and the bureaucrats will wriggle out of the responsibility. It will be the doctors and nurses who allowed all this to happen who will be the ones to pay the price – in their souls if nowhere else.

Despite all this, however, there are still millions of people who believe in the lockdowns and the social distancing. They are terrified out of their wits. And they have frozen in obedience.

THE SECOND CAMP is the smallest of the three. It consists of people who believe the coronavirus scare has been wildly oversold. They realise it is a nasty, infectious bug but having studied the real evidence (or at least as much of it as can be found), rather than the fake evidence dished up by bent and unscrupulous politicians and the headline hunting media folk, they realise that the coronavirus is no more lethal or destructive than a nasty flu bug – and probably not as bad as the worst flu bugs.

The people in this camp are furious at the way the world has been damned near destroyed for no good reason. They know that the whole terrible mess is too stupid to be a cock up. So they are reluctantly coming round to the idea that it is a conspiracy to take away their freedom, their democracy and free speech, to give a bunch of unimaginative dictators the excuse to introduce oppressive and scary laws that wouldn't have been out of place in Stalin's Russia or Hitler's Germany.

They suspect that there is money behind what is happening and they rather fear that if someone found a cheap, safe cure then it would be demonised and banned until an expensive, patented cure could be found and made available at great profit. If you think I am being cynical then that's because you haven't been writing about the drugs industry for half a century.

IN THE THIRD CAMP, which is the second largest group, are the people who don't quite know what to think or who don't have the courage to face the facts. They prefer to let someone else worry and take all the responsibility. They see their country being destroyed but they can't quite find the time to look at the evidence or the courage to question the decisions being made. They are terrified about the future because they can see that the way things are going there probably isn't one. They know that today's children are going to spend their lives impoverished, working hard to pay off the debts incurred as a result of this lockdown lunacy. They know that people with cancer and other serious diseases are dying because they have been abandoned by health care chiefs. But they don't feel they can support one side or the other just yet. They stand outside at the appropriate times and clap the NHS but their hearts aren't really in it.

It is the people in this third group I honestly can't understand. This is a crucial time. It affects our lives now and for the foreseeable future. Generations ahead will be affected by what we do now. The basic question is: are we fighting a virus or are we fighting our governments? It's not a question you can ignore. Everyone has to take sides.

If you decide that the politicians are being honest and that their advisers are competent and accurate then you can put yourself in the first camp and just pray that you'll be saved by the mathematicians with their models and the politicians with their threats and hope that the alleged plague doesn't kill you and your loved ones.

But if you think the politicians are lying, in the way they always do, and that the advisors are plucking figures out of thin air, or that for whatever reason the figures are being manipulated, and the lockdowns are going to do far more harm than good then you are spiritually in the second camp and you should do everything you can to fight for freedom and for our future. You should fight and fight and fight because if you don't then we are all sunk.

I firmly believe that our only hope is to convert as many people as possible from the third group and to persuade them to join the second group. Only when the sceptics outnumber the gullible, will any of us have any sort of a future.

When I try discussing this with people I often get a negative reaction, they won't listen to the facts. People will say: how can you say it is not more dangerous than the normal flu? Workplace Remedy For Mask Diktats

Meanwhile, legally unenforceable demands that people wear face masks at work are becoming increasingly common and should be dealt with in a simple administrative process, using the common law to establish the indisputable facts, which I am in process of drafting a detailed template for. However, in simple terms, if you are threatened with the sack for refusing to wear a mask, you need to send your employer a Notice of Conditional Acceptance, promising to wear a mask if they provide you with the following:

- 1. Evidence that masks prevent infection.
- 2. Evidence that masks don't cause oxygen deprivation which can lead to seizures.
- 3. Evidence that breathing in your own carbon dioxide does not cause bacterial infections and respiratory disorders.
- 4. Evidence that wearing masks does not cause stress and anxiety.
- 5. Evidence that wearing masks prevented the spread of the Spanish Flu.
- 6. Evidence that dismissal for not wearing a mask at work would not represent a material breach of the Equality Act, which entitles you to claim compensation for discrimination, as well as unfair dismissal.
- 7. Evidence that the government lurgy has ever been proven to exist.
- 8. Evidence that the Coronavirus Act and the regulations which arose out of it are not adjudged to be repugnant and void under the common law.
- 9. Evidence that it is not a crime ancillary to genocide to collaborate with government policy, which has already resulted in hundreds of thousands of deaths in care homes and hospitals.

LETTER: The Great Barrington Declaration – As infectious disease epidemiologists and public health scientists we have grave concerns about the damaging physical and mental health impacts of the prevailing COVID-19 policies, and recommend an approach we call Focused Protection.

Coming from both the left and right, and around the world, we have devoted our careers to protecting people. Current lockdown policies are producing devastating effects on short and long-term public health. The results (to name a few) include lower childhood vaccination rates, worsening cardiovascular disease outcomes, fewer cancer screenings and deteriorating mental health – leading to greater excess mortality in years to come, with the working class and younger members of society carrying the heaviest burden. Keeping students out of school is a grave injustice.

Keeping these measures in place until a vaccine is available will cause irreparable damage, with the underprivileged disproportionately harmed.

Fortunately, our understanding of the virus is growing. We know that vulnerability to death from COVID-19 is more than a thousand-fold higher in the old and infirm than the young. Indeed, for children, COVID-19 is less dangerous than many other harms, including influenza.

As immunity builds in the population, the risk of infection to all – including the vulnerable – falls. We know that all populations will eventually reach herd immunity – i.e. the point at which the rate of new infections is stable – and that this can be assisted by (but is not dependent upon) a vaccine. Our goal should therefore be to minimize mortality and social harm until we reach herd immunity.

The most compassionate approach that balances the risks and benefits of reaching herd immunity, is to allow those who are at minimal risk of death to live their lives normally to build up immunity to the virus through natural infection, while better protecting those who are at highest risk. We call this Focused Protection.

Adopting measures to protect the vulnerable should be the central aim of public health responses to COVID-19. By way of example, nursing homes should use staff with acquired immunity and perform frequent PCR testing of other staff and all visitors. Staff rotation should be minimized. Retired people living at home should have groceries and other essentials delivered to their home. When possible, they should meet family members outside rather than inside. A comprehensive and detailed list of measures, including approaches to multi-generational households, can be implemented, and is well within the scope and capability of public health professionals.

Those who are not vulnerable should immediately be allowed to resume life as normal. Simple hygiene measures, such as hand washing and staying home when sick should be practiced by everyone to reduce the herd immunity threshold. Schools and universities should be open for in-person teaching. Extracurricular activities, such as sports, should be resumed. Young low-risk adults should work normally, rather than from home. Restaurants and other businesses should open. Arts, music, sport and other cultural activities should resume. People who are more at risk may participate if they wish, while society as a whole enjoys the protection conferred upon the vulnerable by those who have built up herd immunity.
